

**The Regulation of the Election Commission of Thailand
on the Election Campaign, Code of Conduct, and Prohibitions
governing the Election of Members of the House of
Representatives and Proceedings of Political Parties,
Candidates, and Eligible Voters (No.2) B.E. 2550**

Due to the fact that the Regulation of the Election Commission of Thailand on the Election Campaign, Code of conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters B.E. 2550 deserves an amendment.

By virtue of Section 236 (1) of the Constitution of the Kingdom of Thailand B.E. 2550; Section 5 and 10 (2), (3), (5) of the Organic Act on the Election Commission B.E. 2550; Section 59 Paragraph two of the Organic Act on the Election of Members of the House of Representatives and Selection of Senators B.E. 2550; Resolution of the Election Commission of Thailand No. 91/2550 dated 30 October B.E. 2550, the Election Commission of Thailand hereby issues the Regulation as follows:

Clause 1: This Regulation is called the “Regulation of the Election Commission of Thailand on the Election Campaign, Code of Conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters (No.2) B.E. 2550”.

Clause 2: This Regulation shall come into force as from the day following the date of its publication in the Government Gazette.

Clause 3: A definition of “political party” in Clause 3 of the Regulation of the Election Commission of Thailand on the Election Campaign, Code of Conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters B.E. 2550 is abrogated and shall be replaced by

“political party” means a political party nominating a candidate for an election.

Clause 4: Words in (2) of Clause 4 of the Regulation of the Election Commission of Thailand on the Election Campaign, Code of Conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters B.E. 2550 is abrogated and shall be replaced by

“(2) using a vehicle or arranging a venue or stage in addition to an arrangement of a venue or central stage for an election campaign in accordance with Clause 11 of the Announcement of the Election Commission of Thailand on Rules and Procedures of the State in Supporting the Election of Members of the House of Representatives B.E. 2550”.

Clause 5: Words in (4) of Clause 6 of the Regulation of the Election Commission of Thailand on the Election Campaign, Code of Conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters B.E. 2550 is abrogated and shall be replaced by

“(4) organizing festivity or promising to treat any person”.

Clause 6: Words in Clause 7 of the Regulation of the Election Commission of Thailand on the Election Campaign, Code of Conduct, and Prohibitions governing the Election of Members of the House of Representatives and Proceedings of Political Parties, Candidates, and Eligible Voters B.E. 2550 is abrogated and shall be replaced by

“**Clause 7:** No candidate, political party, nor voter, as the case may be, shall circulate or ask other person to circulate documents of election campaign by air-dropping or putting them in public places”.
